Court Appointed Special Advocates are appointed by the Court judge to represent the best interest of abused and neglected children in the court system. A CASA volunteer acts as the "eyes and ears" of children involved in court proceedings, and offer judges a critical perspective of what is in the best interests of each child, based on information gathered first-hand through research, interviews, and observations. Studies show that once a CASA volunteer is assigned to an abused or neglected child that the child is much more likely to receive vital services such as health care, education, and therapy. By getting involved as a CASA, you can help create healthier families and communities - and change the course of a child's life.

### Featured Resource:



The Family Engagement Center is a place for families to come and gather to learn more about child development, parenting strategies, and developmentally appropriate ways to play with their children. The center will provide an avenue for parents to engage in meaningful play with their children, as well as to allow parents to connect with school staff and other parents. Together parents and children will learn about the world through play, music, art, and books.

The Family Engagement Center is a service provided by Kearney Public Schools. It is open to children age 5 and younger whose families live inside the Kearney Public Schools district area. They have play areas for children 0-3 and 3-5, art and book areas, and computers for parents to use. There is a Family Engagement Specialist to work with parents on parenting skills and interacting with their children. The center also has a lending library of boppy pillows and play mats, developmental toys, children's books, parenting books, and educational toys and games. • Lending Library

Weekly parent-child groups led by the Family Engagement Specialist will be held in the center. These will be based on various topics including social-emotional, cognitive, fine and gross motor, problem-solving skills, etc. In addition, the center will be the location for our Circle of Security-Parenting classes and infant massage trainings.
