
# KEARNEY/BUFFALO COUNTY CASA Fall NEWSLETTER



## New Volunteers: August 2018

Each of these brave volunteers embarked in their journey to becoming CASA Volunteers starting April 3rd, 2018. These volunteers have completed a full 30 hour training. In this training, they learned about their role as a CASA Volunteer, how cases move through the system, who is involved in these cases, the roles of the legal parties, children's needs and development, Child Abuse and Neglect, Trauma and Resilience, Communication and Interviewing, mental health, poverty, professional communication, substance abuse, cultural competence, domestic violence, permanence, educational advocacy, advocating for older youth, and LGBTQ youth. Once these volunteers completed the in-class training, they observed a juvenile court hearing and were then sworn in by Honorable Judge. Each of these volunteers accepted and were assigned a case following their training. We are so blessed to have them and are grateful to the hard work they put in training.



## August 2018 In-Service

We were honored to have Investigator Dan Warrington and DHHS Supervisor, Brenda Rodriguez be our speakers at our In-service. We had 39 CASA Volunteers that came from Hastings, Kearney, Minden, Lexington, Holdrege and Alma to learn from Investigator Warrington and DHHS Supervisor Rodriguez. At our in-service, CASA volunteers were able to earn 3.5 CUE's.

Investigator Dan Warrington is with the Kearney Police Department, Nebraska ICAC Task Force, Special Deputy US Marshal-F.B.I. CETF and Special Deputy State Sheriff-ICAC. Investigator Warrington shared about the Dark Web, a collection of websites within an encrypted network. The Dark Web is riddled with child pornography and predators. The group learned about bullying, child enticement and how to search on the Sex Offender Registry. We also learned more about what to look for as indicators of sexual abuse and indicators of an offender.

Brenda Rodriguez is a CFSS Supervisor with DHHS in Kearney. Most of the CASA's are used to knowing that families need services and then they receive them. Brenda went through the process of how services are put into place. She helped us to understand how the HHS caseworkers first use a Provider Service Referral and send that out to the providers stating exactly what is needed in detail. We learned who pays for the services and the different resources they use.



# September 2018 Advocate of the Month: Samantha Arehart

Samantha has worked very hard to get to know her family and because of this has been able to help them all immensely whether it be recommending additional resources or the giving of her time. Samantha is an amazing advocate for these children and works very hard to give her best no matter what is asked of her. Her knowledge and input has been very valuable throughout her case and she has proven to be a strong advocate in helping to make sure any decisions made are the best option possible for the children and their family."

Samantha Arehart states "I have always had a passion for foster care, but am not yet in a season of my life where taking in a foster child is an option. However, I kept getting called back and didn't know where God was leading me. One of my good friends had recently adopted her foster son and was telling me about her CASA and what a difference they made in her case and I was like "what in the world is a CASA?" After she explained that it was volunteer based I immediately knew that's what I was being called to. It is a privilege that I am given the opportunity to provide support for not only these children for the entirety of their time in the system, but their mommas, their foster parents, and even bridge communication between different parties on the case including attorneys and case workers. To be a CASA is to be the voice for your foster child and to be a face that is present and positive for the entire team in a way that can truly make a difference in both the outcome of the case and these families' lives forever."

## October 2018 Advocate of the Month: Tiffany Coufal





# November 2018 Advocate of the Month: Denise Bryan



Kearney/Buffalo County CASA is proud to honor Denise Bryan of Pleasanton for her advocacy for abused and neglected children. Kathy, CASA Volunteer Supervisor states "Denise has been a volunteer with CASA since April and has served on two cases. Denise is just one of those people you can ask to do something and you know it will get done. I believe with Denise's experience she is able to put everyone at ease and make them feel very comfortable and welcome. Denise is very organized and detail oriented which makes for an awesome volunteer. Denise puts in many hours a month being an advocate not only to the children in her case, but also to the parents when needed. Denise has a very kind heart and it shows through her volunteering. Although each case is unique in its own way, one thing that doesn't change is Denise's positive attitude in regards to making her CASA family whole again. "

Denise Bryan states "I grew up in a home with loving parents who took the time to meet our needs as well as create individual relationships with all five of us children. They were excellent role models while doing so. As a child myself, I saw kids I knew struggle with abuse and neglect. At that time, I believed I helped by befriending them. Those were memories of feeling helpless to make things better but still hoping for something better. Then in later years, as a teen, I

realized that kids don't tell. They suffer silently or together, still loving the adults that are mistreating them. Through the years I continued to see children that wouldn't tell and suffered. These children were overlooked partly because the signs they displayed weren't recognized as warning signs. My heart and soul have been burdened since I can remember for these children. Some of them have grown to be adults and still suffer from their past. I've been able to help at times and at other times said prayers from a distance. Several years ago, the HUB ran an article about CASA to which my interest to participate was great but the needs of my own family were foremost and prevented a decision to participate. Recently at the beginning of this year, a colleague and I discussed their involvement with CASA and what was required. After that discussion, I felt in my heart that it was time to get involved. This is an opportunity to love these children, to be someone they can trust, to be their friend, and to be their voice to the court. I am honored and grateful to be able to be a part of the CASA program—to make a difference in the life of a child."

So many times we as adults assume we know what's best for our kids, when in fact if we would take the time to listen to our kids we could save them from the abuse and neglect and give them a happy home, a place to always call home. Besides being a mother and step-mother of 5 amazing children, CASA is the most rewarding journey I have done in my life thus far. There are still more children in our area that desperately need a CASA Volunteer. I encourage anyone to take some time out of their own lives and go through the training and become a voice for our children; they deserve to have someone in their corner. 
#### **GIVE WHERE YOU LIVE**

When a child is abused/neglected by a parent/guardian, they may be removed from the home for their safety. The child enters the foster care system and is placed with family/foster family. A court case is opened and the parent/guardian has a chance to regain custody by following the courts orders. Meanwhile, the child may experience many challenges, like placement changes, changing schools, loss of family connections, physical/emotional/health issues, etc. This is where CASA comes in. A CASA offers a child trust and advocacy during complex legal proceedings.

Court Appointed Special Advocates are appointed by the Court judge to represent the best interest of abused and neglected children in the court system. A CASA volunteer acts as the "eyes and ears" of children involved in court proceedings, and offer judges a critical perspective of what is in the best interests of each child, based on information gathered first-hand through research, interviews, and observations. Studies show that once a CASA volunteer is assigned to an abused or neglected child that the child is much more likely to receive vital services such as health care, education, and therapy. By getting involved as a CASA, you can help create healthier families and communities and change the course of a child's life
