In this training, they learned about their role as a CASA Volunteer, how cases move through the system, who is involved in these cases, the roles of the legal parties, children's needs and development, Child Abuse and Neglect, Trauma and Resilience, Communication and Interviewing, mental health, poverty, professional communication, substance abuse, cultural competence, domestic violence, permanence, educational advocacy, advocating for older youth, and LGBTQ youth. Once these volunteers completed the in-class training, they observed a juvenile court hearing and were then sworn in by Honorable Judge. Each of these volunteers accepted and were assigned a case following their training. We are so blessed to have them and are grateful to the hard work they put in training.



Click Family Health provides Direct Primary Care services as part of a membership. The Click Family Healthcare does not participate in any insurance plans, which allows them to avoid costly documentation and administrative demands that come along with accepting insurance. They avoid the patient data collection and overall save money.

Some of the services they offer in their membership include but are not limited to the following:

- Preventative Health Care
- Acute care and chronic disease management
- EKG, Spirometry, and breathing treatments
- Mental health, including treatment for depression, anxiety and mood issues.
- School, sports, and workplace physicals
- Treatment of sprains and simple fracture care, office procedures including laceration repair, skin lesion removal, biopsy of suspicious skin lesions
- Cryotherapy
- Joint injections
- Vasectomies
- Women's health,
- Well checks for infants and children.

Also as part of the membership, patients have same day or next day appointments based upon medical need.

"The reason I chose to become a CASA volunteer- There have been experiences throughout my life that I have found myself in a situation that I could help a child/and or an adult get out of a bad situation or help steer them in the right direction and get them the help they need. I have always been passionate about helping others where and when I could. When I first heard about CASA I didn't have to think twice about joining. I thought to myself, this is where I'm supposed to be. So I messaged a friend of mine and asked how and where to go to sign up. So many of our children do go unheard and get lost in our system only to be left most times another statistic. If there is just 1 person that can take a few hours out of their already crazy, stressful, busy lives to be there for a child in the foster care system and give them a voice in our court system, and just be there for them to let them know that they do matter to someone, they could change so many lives for the better. So many times we as adults assume we know what's best for our kids, when in fact if we would take the time to listen to our kids we could save them from the abuse and neglect and give them a happy home, a place to always call home. Besides being a mother and step-mother of 5 amazing children, CASA is the most rewarding journey I have done in my life thus far. There are still more children in our area that desperately need a CASA Volunteer. I encourage anyone to take some time out of their own lives and go through the training and become a voice for our children; they deserve to have someone in their corner. It hadn't even occurred to me that arrangements needed to be made, because in my life holidays with family just happen. Being able to help facilitate something that seems so small, but is so important to the child, is important to me. Being able to help her have a voice, to help her be heard ensures that when the team makes decisions they can take her wishes into consideration."

Court Appointed Special Advocates are appointed by the Court judge to represent the best interest of abused and neglected children in the court system. A CASA volunteer acts as the "eyes and ears" of children involved in court proceedings, and offer judges a critical perspective of what is in the best interests of each child, based on information gathered first-hand through research, interviews, and observations. Studies show that once a CASA volunteer is assigned to an abused or neglected child that the child is much more likely to receive vital services such as health care, education, and therapy. By getting involved as a CASA, you can help create healthier families and communities and change the course of a child's life
