Child and Youth Court Forms

Ever been at a loss about how to best present your CASA kiddo's wishes and desires to the court? The Through the Eyes of the Child Initiative has created 2 helpful forms for this purpose of allowing children to communicate their wishes and desires to the Judge.

The form pictured is the first page of the form intended for children who are developmentally age 6 to age 10. It is colorful and intended to be completed by the child with assistance as needed from a trusted adult. A form for older youth is also available and can be completed on their own or with assistance as needed.


If the child has a therapist, the preference is that the child would complete the form with the therapist. If no therapist is involved, please visit with your team to determine which team

member would be most appropriate to assist the child with completing the form.

Both forms can be located on the Through the Eyes of the Child website under the youth and families tab. Click on youth in the left sidebar and the court forms show up as options underneath youth in the sidebar.

If you prefer, feel free to speak with


your supervisor about getting a copy of the forms from the CASA office.



CEU Central: Anne of Green Gables

Anne of Green Gables in a novel about Anne, a young orphan, who is sent to Prince Edward Island after a childhood spent in strangers' homes and orphanages. Marilla and Matthew Cuthbert, siblings in their fifties and sixties, had decided to adopt a boy from the orphanage to help Matthew run their farm. They live at Green Gables, their Avonlea farmhouse on Prince Edward Is-

land. Through a misunderstanding, the orphanage sends Anne Shirley. Anne is described as bright, eager to please, talkative, and extremely imaginative. She has a pale face with freckles and typically braids her red hair. Marilla at first says the girl must return to the orphanage. Marilla feels that she could be a good influence on the Anne and chooses to let her stay. As a child of imagination, Anne takes much joy in life and adapts quickly, thriving in



the close-knit farming village. Her talkativeness initially drives the prim, duty-driven Marilla to distraction, although Matthew falls for her charm immediately. Anne says that they are "kindred spirits." Following the novel, a movie series was created.

Trish is a retired educator who most recently worked as a Professional Development Coordinator with Educational Service Unit 10 and previously as Assistant Professor of Education and Ombudsperson at UNK. On her first case as a CASA volunteer Trish has shown a mastery of her role as a CASA volunteer. She meets with her CASA kiddos each month and has managed to build

rapport with them despite differences in culture and language. Trish spends the time each month to investigate the case by visiting with the school, therapists, the caseworker, biological parents, and foster parents. She thoroughly reports any information she gathers to the team at team meetings. As an educator and the placement coordinator for Royal Family Kids Camp she was aware of and helped locate camps, summer activities, and tutoring for the children. Trish says "I am so honored to be considered for this recognition so early in my service as a CASA volunteer. An educator by profession, taking on this role was on my "back burner" for several years. Setting aside time for the training seemed to be my stumbling block...and, as it turns out, that was a misperception. It is a privilege to advocate for the best

interests of some very special children, useful and thought-provoking to learn about the foster care system, and a pleasure to collaborate with my supervisors, the case worker, and attorneys who so thoughtfully offer their expertise to improve the lives of children. I am drawn to the children and to do what I can to move them toward experiences and relationships that are safe and offer hope and opportunity for a healthy fu-

ture."


June Volunteer of the Month





Court Appointed Special Advocates are appointed by the Court judge to represent the best interest of abused and neglected children in the court system. A CASA volunteer acts as the "eyes and ears" of children involved in court proceedings, and offer judges a critical perspective of what is in the best interests of each child, based on information gathered first-hand through research, interviews, and observations. Studies show that once a CASA volunteer is assigned to an abused or neglected child that the child is much more likely to receive vital services such as health care, education, and therapy. By getting involved as a CASA, you can help create healthier families and communities - and change the course of a child's life.

Featured Resource: Resource Binder, Nebraska Department of

Corrections Inmate Locater, Vinelink, and Justice!

- ~Looking to help your family locate resources? Located in Volunteer Supervisor, Margot Icenogle-Larsen's office is a resource binder packed with tons of resources within our very own community. Resources will continue to be added to this binder and will be available to all of our staff and volunteers.
- ~Nebraska Department of Correction Inmate Locator is a great resource to locate an individuals who are incarcerated and to also see how long they will remain incarcerated. This website will also show you what they are incarcerated for, when the individual is qualified for parole, the offense and the possible time it carries, and their projected release date. The website is: http://dcs-inmatesearch.ne.gov/Corrections/COR input.html
- ~Vinelink is a great tool to look up and verify if an individual is currently incarcerated. Information provided will be their name, where they are located and if they are in or out of custody. You can sign up for notifications for any changes of custody. The website is: https://vinelink.com.
- ~Justice is another great tool! Justice is a site in which court documents from either Criminal Court and Juvenile Court can be seen, next court dates, the history of the case. There is a computer in the lobby of the court complex that you can access Justice on or you can set up a time with your supervisor to view Justice.
