

# **Volunteer Training**




The volunteers were sworn in on September 2, 2019 after 4 weeks of training.

#### Kent E. Lilly December 9, 1946-August 25, 2019



When we heard about the passing of Kent Lilly, the staff at Kearney/Buffalo County CASA were deeply saddened and wanted to reflect on Kent and his humanitarian spirit. Kent spent his life looking out for others and helping everyone he could. Kent began his CASA journey in April of 2014 when he completed the New Advocate 30-hour pre-service training. He served as a CASA advocate in over two cases from 2014 to 2019 and spent many hours working with his CASA family, totaling 76.9 hours. Some of the children he served were not placed in Kearney and he spent a lot of time on the road, totaling 803 miles. In addition to all of the time and miles, Kent continued to earn continuing education credits. He put in 23.25 continuing education credits during his time with CASA.

Kent gave so much to CASA and the CASA children he served. Kent has helped so many in his life along the way. Kent enlisted with the U.S. Air Force and served for four years. Upon his discharge from the Air Force, he attended Kearney State College and earned a bachelor's degree in business administration.

He married JoAnn in 1967.

Kent served the state of Nebraska as a state probation officer in Kearney. He was appointed a chief probation officer in 1979 serving nine Nebraska counties in what was then referred to as Probation District 17. Following a restructure in the probation system, he served as chief deputy probation officer in District 9 serving Buffalo and Hall counties. He ended his decorated career in 2012 after 40 years of dedicated service.

During his career, he served on many committees both as an adviser and chair, including Region III Alcohol Advisory Services Board, statewide policy procedure committee and others. He was instrumental in helping write statewide policies over the years. He also helped to establish the Kearney Probation Reporting Center, which now offers a wide variety of services to offenders. In 2006 he was awarded the Nebraska Probation System Supervisor of the Year award.

Kent was an active member of First Presbyterian Church where he served as a deacon and elder. He also served as a scoutmaster of Boy Scout Troop 136.

Kent will always be remembered for his heart and strong will to serve others.

It is our Honor and Privilege to award Kent Lilly as CASA Advocate of the Year for Two-Thousand Nineteen. This is the first year this award has been given to anyone and we couldn't be more proud to have this go to Kent. Kent's supervisor Kathryn Nantkes states, "When those of us here at CASA made the decision to honor our very first CASA Advocate of the Year, we all knew right away we wanted our first one to be Kent. Kent has just been such a huge blessing to CASA and he has given so much of his time to all of his cases and to the children that are involved, and has accepted them with absolutely no complaints and always with a smile on his face."

"Upon retirement, having served the Nebraska Courts, both in the Juvenile and Adult arenas for 40 years, I felt compelled to see if I might be able to make a difference with some of these Dependent and Neglected kids, in an effort to help them avoid making poor choices and ending up in adult court later on. So many of these kids, especially the older ones, become numb to the idea of sitting in court hearings, time after time. # Why I Volunteer

"I grew up in a home with loving parents who took the time to meet our needs as well as create individual relationships with all five of us children. They were excellent role models while doing so. As a child myself, I saw kids I knew struggle with abuse and neglect. At that time, I believed I helped by befriending them. Those were memories of feeling helpless to make things better but still hoping for something better. Then in later years, as a teen, I realized that kids don't tell. They suffer silently or together, still loving the adults that are mistreating them. Through the years I continued to see children that wouldn't tell and suffered. These children were overlooked partly because the signs they displayed weren't recognized as warning signs. My heart and soul have been burdened since I can remember for these children. Some of them have grown to be adults and still suffer from their past. I've been able to help at times and at other times said prayers from a distance. Several years ago, the HUB ran an article about CASA to which my interest to participate was great but the needs of my own family were foremost and prevented a decision to participate. Recently at the beginning of this year, a colleague and I discussed their involvement with CASA and what was required. After that discussion, I felt in my heart that it was time to get involved. This is an opportunity to love these children, to be someone they can trust, to be their friend, and to be their voice to the court. I am honored and grateful to be able to be a part of the CASA program—to make a difference in the life of a child." - Denise Bryan



Court Appointed Special Advocates are appointed by the Court judge to represent the best interest of abused and neglected children in the court system. A CASA volunteer acts as the "eyes and ears" of children involved in court proceedings, and offer judges a critical perspective of what is in the best interests of each child, based on information gathered first-hand through research, interviews, and observations. Studies show that once a CASA volunteer is assigned to an abused or neglected child that the child is much more likely to receive vital services such as health care, education, and therapy. By getting involved as a CASA, you can help create healthier families and communities and change the course of a child's life.
