Every year, more than 3 million children nationally are reported abused or neglected. Here in Kearney and Buffalo Counties we see an average of 60 new cases each year. Despite the states' attempts to help, many of these kids become trapped in the court and child welfare maze and can spend their childhood moving from one temporary shelter to another. This is where a CASA volunteer comes in.

CASA Volunteers are everyday citizens who volunteer their time to be the eyes and ears of the court in abuse and neglect cases to provide the court with an independent report of the facts of the case and to advocate for the best interests of the child.
